☐ Step 1

Log in to your Company Profile at <https://www.kellysolutions.com/ga/Structural/UpdateInfo/Login.asp>

Pro Tip: Make sure you are logging in using your company license number and not logging in under your license number. The company page will have different options available.

☐ Step 2

Scroll down the page and click on the red text that reads "Add Registered Employee". The screen will look like the image below with a list of employees who are currently registered with the company. This will open a pop-up box or new browser window.

What if they have an SP number already? or What if they have never been registered before?

If you are adding a registered employee who had been previously registered or already has an SP number, proceed to step "3A - Employees with an SP Number". You may skip steps in this guide labeled as "3B"

If you are adding a registered employee who has never held a license before and does not have an SP number, then please skip ahead to the section of this guide titled "Step 3B - First Time Registered Employees" on the next page.

☐ Step 3A - Employees with an SP Number

For employees who are already registered, enter their license number in the search box including the "SP", and click "Search".

Step 4A - Employees with an SP Number

Then click on "Select" for the registered employee you'd like to add. After you have clicked on "Select" it will take you back to the previous page. If you have more than one employee to register, you can repeat steps 2 through 4 to add each employee before proceeding to step 5 to complete payment.

Step 3B - First Time Registered Employees

For employees that are being registered for the first time, you will instead click on the blue "click here" link.

Step 4B - First Time Registered Employees

Clicking on the link will open a new window where you will then fill out all of the employee's information.

Be sure to fill the information out completely and accurately, taking special note to check all the pest control categories that the registered technician will operate in at your company.

At the bottom of this screen, the DCO should verify all the information and enter their SP number. Then click the "Save & Confirm for Payment" button. If you have more than one employee to register, you can repeat steps 2 through 4 to add each employee before proceeding to step 5 to complete payment.
