Application: External adjuvant is not needed when applications are made to grasses that are actively growing. Sequential applications can be applied as needed. For annual grasses not listed, only suppression can be expected. To ensure control of perennial grasses or annual grasses not listed, add a Non-ionic Surfactant (NIS) at 0.125% v/v but expect visual injury.

For repeat applications, make on a minimum of a 14 day interval.

²Rate may be increased up to 16 fl oz/A but crop injury is more likely as rate is increased.

RESTRICTIONS

- Do not exceed 16 fl oz/A in a single application.
- Do not exceed 16 fl oz/A for Pea (shelled) and Edible Podded Legume Vegetables (one application per season). For all other crops, do not exceed a seasonal total of 64 fl oz/A.
